Voting Guidelines

Voting Requirements:

- Be registered to vote in Virginia
- Be a US citizen
- Be 18 by Election Day, Nov. 7
- Reside at a Virginia address
- Not be convicted of a felony, unless your voting rights have been restored
- Not currently judged incompetent by a court

In-person ID requirements:

- A Virginia driver's license or Photo ID
- A Veteran's ID from Virginia DMV
- US Military ID
- A US Passport
- · A student ID issued by a Virginia college or private school

Voting in Person:

- Early Voting: Sept. 22 to Nov. 4
- Vote on Election Day, Nov. 7

Absentee Ballots:

- Deadline to request an absentee ballot by mail is 5 p.m. Tuesday, Oct. 31
- Deadline to request an absentee ballot in-person is 5 p.m. Saturday, Nov. 4






